

# Code Nation Privacy Policy

## Policy Statement

The term 'we', 'us', 'our' refers to the owner of the website: Code Nation Ltd, registered at and operates from The Vault, 8 Boughton, Chester, CH3 5AG. Code Nation is registered in England and Wales 08495005. The term 'you' refers to the user or viewer of our website.

This privacy policy sets out how we use and protect any information that you provide us when you use our website.

We collect data from visitors to our website to help improve and streamline our online services, as well as gauge the volume and analytical data of website traffic, and capture data supplied by our customers for either services or functionality built in to our website.

## Our commitment

We are committed to providing transparency and visibility to the services we use to capture and manage data when visiting our website.

We have compiled a table below of the services we employ to capture and manage data via our website. Each external service such as AWS, ZohoOne, etc have their own set of privacy policies which outlines how they manage the data passed through to their services. For ease of our visitors we have provided links to their respective websites and privacy policies.

## What data does our website collect and how do we store and use it?

Web Hosting Server	<p>Our web hosting server is the server on which our website is stored and served to the world.</p> <p>Our web server logs a visitors' IP address which helps it to mitigate attacks from bots and filter out good/bad traffic.</p>	<p>Logs are kept by the web hosting company, they are cleared periodically and save no personal data about the users visiting our website.</p>
Zoho Pagesense	<p>As part of our Zoho One system we use Pagesense for website Analytics. PageSense's activities, like tracking visitor behavior on websites and targeting specific visitors for A/B tests, generate data that's considered private under GDPR. All of this tracked data is stored with anonymized IP addresses, so we can safely capture, process, and use it without infringing on visitors' data privacy. PageSense doesn't collect personal data from any website visitor who participates in any experiment. The cookie data used to map experiments isn't associated with any IP address.</p>	<p>Zoho data is stored on their cloud servers, with only CodeNation designated staff, who require access, have access through 2 factor authentication enabled.</p> <p>Zoho Pagesense is completely GDPR compliant and for more information on please see here:  <a href="https://www.zoho.com/pagesense/gdpr.html">https://www.zoho.com/pagesense/gdpr.html</a></p>
Zoho SalesIQ	<p>As part of our Zoho One system we use SalesIQ for client live chat and messaging. If a site visitor wishes to communicate with a Code Nation team member, they will be notified that some information is collected, such as name and email address, if they wish to communicate with Code Nation, however this is provided by the visitor should they wish to 'opt in'. Tracking data is stored with anonymized IP addresses, so we can safely capture, process, and use it without infringing on visitors' data privacy.</p>	<p>Zoho data is stored on their cloud servers, with only CodeNation designated staff, who require access to communicate as operators, or monitors,, have access through 2 factor authentication enabled.</p> <p>Zoho SalesIQ is completely GDPR compliant and for more information please see here:  <a href="https://www.zoho.com/salesiq/gdpr.html">https://www.zoho.com/salesiq/gdpr.html</a></p>



<p>Website Security Plugins</p>	<p>Our website has several security plugins installed to help us keep the bad-bots at bay.</p> <p>Websites are constantly targeted with malicious scripts, DDOS attacks, malware, spam and a handful of other harmful processes. We proactively mitigate these attacks outlined above by the security software installed on our web hosting server, via Cloudflare and by software installed directly on our site.</p> <p>These security plugins do not capture any personal or sensitive data about our visitors</p>	<p>Our website security plugins log a visitors' IP address which helps it to mitigate attacks from bots and filter out good/bad traffic. These logs are cleared out periodically.</p>
<p>Contact and Booking Forms</p>	<p>Online forms are a convenient way to submit your enquiry which in-turn is emailed directly to ourselves and is also stored in our website database.</p> <p>Our data forms capture your name, your phone number, your email address and any further information you provide to us in your enquiry.</p>	<p>Your submission is stored in our website database and is also sent to ourselves via email.</p> <p>The data stored in our database will be held indefinitely until our database is no longer in use or you request to have the data expunged from our server.</p> <p>The data is kept on file should we need to refer back to it to process your request.</p>
<p>Log In Log</p>	<p>Our website keeps a log of any existing users who have logged in to our website.</p> <p>This mainly pertains to registered users of our website including administrators, editors, authors, subscribers and other user roles defined by ourselves.</p>	<p>Logs are kept on the server and they are cleared periodically and save no personal data about the users visiting our website.</p>
<p>Posts Comments</p>	<p>WordPress is a highly developed blogging platform which is the core that our website runs on. Blog posts have the option to allow visitors to our site to comment on individual articles which requires data to be supplied by the contributor.</p> <p>This data can be as limited to a guest contributor which captures basic data such as your screen name and email address or as a registered user on our website it can include a username, your full name, your email address, your IP address, your social media handles and your photo, should you wish to upload one via the website or a Gravatar service.</p>	<p>The data stored in our database will be held indefinitely until our database is no longer in use or you request to have the data expunged from our server.</p> <p>Any passwords set on our systems are encrypted with an MD5 algorithm and so are not in plain text as you will have set them.</p>

## Controlling your personal information



You may choose to restrict the collection or use of your personal information in the following ways:

- Whenever you are asked to fill in a form on the website, look for the box that you can tick or untick to indicate that you do not want the information to be used for direct marketing purposes
- When subscribing to a mailing list you will be asked to double opt-in to ensure you are the intended recipient of the mailing list and to also confirm that you are
- If you have previously agreed to us using your personal information for direct marketing purposes, you may change your mind at any time by unsubscribing via the link in the last communication or by contacting us directly

- Other information relevant to customer surveys and or offers

## Ways in which our website may capture your personal information

- By filling in and submitting a contact form or booking form
- By subscribing to a mailing list
- By using social media links
- By interacting with an online chat client
- By commenting on posts or pages on our website

## Analytics and web tracking

Our website has tracking software installed which allows us to analyse website performance, it is Zoho Pagesense. PageSense's activities, like tracking visitor behavior on websites and targeting specific visitors for A/B tests, generate data that's considered private under GDPR. All of this tracked data is stored with anonymized IP addresses, so we can safely capture, process, and use it without infringing on your data privacy. This service does not reveal any personal information about our visitors, it simply shows us, in a set period, how many people have visited our website, which town or city they have come from, what search term they used to find us, what type of device was used in their session and what language they speak. No personal information such as name, address or contact information is collected.

## What we do with the information we gather?

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Internal record keeping
- We may use the information to improve our products and services



- We may periodically send promotional emails about new products, special offers or other information that we think you may find interesting using the email address that you have provided
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone or postal mail. We may use the information to customise the website according to your interests
